# Conditions of Sale

1. All sheep have been entered by members of the Association on the prescribed form and are the progeny of Welsh Mountain Ewes and Pedigree Border Leicester Rams.
2. Decisions made by the Association's appointed officials at sale are final.
3. The highest bidder shall be the purchaser, and if any dispute shall arise between two or more bidders, the lot in dispute to be put up again at the sum last bid, or the Auctioneers may declare the purchasers.
4. The biddings to be ruled by the Auctioneers and shall not be less than £1.
5. No person shall retract a bidding without permission of the Auctioneers, who reserve to themselves the right of refusing a bidding and also the right of withdrawing and lot or lots from the sale.
6. The purchasers to declare their names and addresses and, if required, to pay the Auctioneers, or their Clerks the amount of the purchase money immediately on the fall of the hammer and in default of which the Lot or Lots shall be offered again and re-sold, and under no circumstances must any Lot be removed without first obtaining a pass from the Clerk. Persons who are not known to the Auctioneers and intend making purchases must bring a Banker's reference or other approved security for their satisfaction.
7. The Association, through the Auctioneers, reserve the right of deviating from the Catalogue either by amalgamation, dividing or withdrawing the lots prior to or during sale as circumstances may require: and also of deviating from the order of sale.
8. The Lots to be under the immediate care of purchasers, who must remove same at their own risk, on the day of sale, and no purchase shall be allowed to be removed from the premises during the time of sale nor until the whole of the purchase money is paid.
9. The Vendor guarantees sheep to be sound in mouth, udder and feet on day of sale. In the case of any complaint, buyers must notify the Auctioneer within 48 hours of the closure of sale in regard to cases of Foot rot and Orf and within 7 days of the sale in regard to teeth and udder. The decision of the Association shall be final.  
Yearling Ewes must not show more than two broad teeth. Ewes of two-year old and over showing forward must be declared at the time of sale otherwise they may be returnable. No ewe shall have run with the ram prior to the Sale and Vendors will be held responsible if in default. A Vendor, having allowed a Wether Lamb to pass through the Sale and sold as a Ewe Lamb, will not be paid for the Lamb and the buyer will be refunded the amount paid by him for the Ewe Lamb, vendor losing all claims provided the Auctioneers are informed within fourteen days.
10. Upon failure of complying with the above conditions, the uncleared lots will be re-sold, either by Public or Private Sale, and the deficiency (if any) and all expenses attendant thereon shall be made good by the defaulters at this Auction, who shall have no claim for any surplus that may arise.
11. All entries are accepted subject to the foregoing conditions.
12. No set-off or deduction will, under any circumstances be allowed.
13. Under the Welfare of Livestock (Prohibited Operation) Regulation 1982 Short Tail Docking of Sheep, producers must take note that all female sheep must comply with this regulation which states that tails must be long enough to cover the vulva. Ewes or Ewe Lambs found to have tails which do not comply with the above regulation on the day of sale may be returned within one hour of the close of sale by the buyer.

# **SPECIAL RULES FOR BUYERS/VENDORS TO COVER COVID-19 REGULATIONS**

## **Please Note**

To enable us to conduct all livestock sales under Government Guidelines regarding COVID-19 we would appreciate that all **VENDORS** and **BUYERS** adhere to the following rules:

1. All potential purchasers **MUST REGISTER** with the livestock office **prior** to sale on 01824 705000.
2. Buyers/Vendors are recommended to attend themselves with no other family members / friends to accompany them, thus taking the space of other potential buyers.
3. The auctioneers would advise the wearing of face masks on the premises (please provide your own).
4. The 2 metre distancing rule must be adhered to at all times.
5. All stock for sale may be viewed in the pens prior to sale for **Registered** buyers only.
6. It is advised that no children accompany their parents to the sale premises.
7. Hand sanitisers are available throughout the market for regular use by everyone attending.
8. The use of any camera or video recording is prohibited on the market premises.
9. All customers attending are required to sign-in to the premises and will be required to declare that they have not been in contact with anyone displaying symptoms or are not personally having any symptoms of COVID-19. This is required for the Track and Trace system.
10. This information is correct at the time of printing and is subject to changes in Government Guidelines or Directives regarding the control of the spread of COVID-19.

It is the responsibility of the Vendor to draw his/her ewes or lambs in even matching lots – failure to do so may make lots liable to rejection.

Members with more than one Lot in their consignment must mark each pen with a different mark.

All Vendors are requested to make contact with their buyers before leaving the sale and to assist wherever possible after the sale.

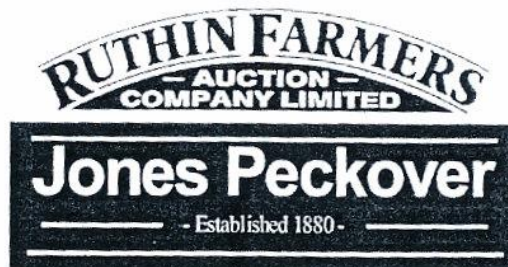
